• Mandatory for Indian legal entities.

# 2. Certificate of Incorporation / Registration Certificate

• Issued by MCA (for companies/LLPs) or Registrar (for societies, trusts, etc.)

#### 3. Entity Proof / Authority Document

## Any one of the following:

- GST Registration Certificate
- Shop and Establishment Certificate
- MSME/Udyam Registration
- SEBI Registration (for financial entities)
- Trust Deed / Society Bylaws (for non-profits)

### 4. Authorized Signatory Identity Proof

- PAN & Aadhaar of the authorized person
- Board resolution / authorization letter authorizing the individual to apply

### 6. LEI Registration Form / Declaration

 Provided by the Local Operating Unit (LOU), such as Legal Entity Identifier India Ltd. (LEIL – a subsidiary of the Clearing Corporation of India Ltd)
